## 2. **General conditions in respect of officers at A, B, C:**

2.1 **Seniority and Date of Effect:** In strict compliance with the principles laid down by the Hon'ble Supreme Court in Shri K. Meghachandra Singh judgment, the seniority of all officers shall be reckoned strictly from the date on which they are officially borne in the cadre upon their actual physical assumption of charge.

2.2 **Retrospective Limitation:** No retrospective seniority, notional promotion or back-dated financial benefit shall be admissible prior to the date of actual entry into the cadre, as an employee cannot claim seniority from a date prior to their actual induction into the cadre.

2.3 **Financial Protection:** This re-allocation of Vacancy Year carries no element of notional pay escalation or retrospective pay fixation, stepping up of pay or financial entitlement accrue from the revised vacancy year. Pay remains fixed as per actual physical assumption of charge of the promoted post.

## 2.4 **VIGILANCE / DISCIPLINARY CASES, IF ANY:**

(a) If there is any vigilance/disciplinary case as referred to in DoP&T O.M. No. 22011/2/86-Estt.(A) dated 12.01.1988 issued by DoPT circulated vide this office memo No. 25-19/88-SPG dated 04.05.88 (subsequently) revised vide DoPT memo No.22022/4/91-Estt.(A) dated 14.09.92 circulated vide this office Memo no. 25-19/88-SPG dated 13.10.92 is pending against the officials, **the official should not be relieved for posting without obtaining specific order from this office.** The promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated, except the circumstances when the officer is under suspension or a charge sheet has been issued to the official or prosecution for a criminal charge is pending against the official. The official against whom any punishment is current except censure and recovery of money, they should not be promoted before expiry of currency of punishment. **An intimation report may be furnished immediately to the Postal Directorate.**

(b) The instructions issued by Personnel Division (SPN-II) section vide its letter No. SPN X-7/6/2022-SPN-II dated 17.05.2023 will be ensured by the circles.

3. **GENERAL CONDITIONS in respect of officers at C:**

3.1. The above allotment has been approved by the Competent Authority based on recommendations of the "Transfer and Placement Committee" as constituted vide Postal Directorate letter No. 4-09/2011-SPG (Pt.) dated 30.03.2015 and transfer/posting instructions/guidelines contained in Directorate letter No. 9-23/2014-SPG dated 25.02.2020.

3.2. *Inter-se* seniority of the selected officers will be fixed by Personnel Division in due course.

3.3. Re-allotment requests, if any, shall not be entertained before completion of tenure as envisaged in this Directorate letter No. 9-23/2014-SPG dated 25.02.2020.

3.4. It is the responsibility of the officer to send a copy of the charge report through the Head of Circle/Director, PTC concerned on assumption of charge on the promoted post to SPG-II Section, Postal Directorate, New Delhi-110001 for information.

3.5. Officers will be relieved within 15 days from the date of issue of this order. In case, posting order from the allotted circle is not received, the relieving circle shall relieve the promoted officer and ask the officer to report to the allotted circle headquarters. Officers allotted to Postal Directorate will report to the Personnel Division of Postal Directorate, Dak Bhawan, New Delhi-110001.

3.6. In case of officer (s), who is not willing to accept his/her promotion, his/her declination letter in writing duly forwarded by the Circle Office should reach this Directorate within 30 days of issue of this order. Non-assumption of charge within 30 days without valid reason will be treated as deemed declination of promotion.

3.7. **PROBATION PERIOD:**

The officials who have been promoted to Postal Service Group 'B' will be on probation for two years and then their suitability to hold the post will be adjudged on completion of probation. If any official proceeds on leave for a period exceeding 30 days during this period, the probation will be extended depending upon the period of leave.

3.8. **TRAINING:**

The officials will be directly promoted to Postal Service Group 'B' cadre without any training for the present. However, they will have to undergo prescribed training as and when notified by the Director, Rafi Ahmed Kidwai National Postal Academy, Ghaziabad.

3.9. **OPTION FOR FIXATION OF PAY:**

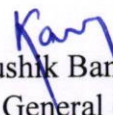
